 Our Social Services Program provides short-term assistance via Basic Needs distributions of free food/clothing/household items multiple times each week. The purpose of these distributions is to ensure that first, families do not go without these basic items and second, that by accessing these items at MORE for no cost, that might free up their current financial resources to be used to support their families in other ways. Our Social Services team also works to ensure our participants have continued access to important community resources via Case Management services.
